GARDA PROPERTY GROUP - DISTRIBUTION COMPONENTS FOR NON-RESIDENT WITHHOLDING TAX PURPOSES

GARDA Holdings Limited (**GHL**) and GARDA Capital Limited as responsible entity of GARDA Diversified Property Fund (**GDF** or **Fund**), together form a GARDA Property Group (**GARDA**) stapled security comprising a share in GHL and a unit in GDF.

GARDA considers the Fund to be a withholding managed investment trust for the purposes of Subdivision 12-H and Division 12A of Schedule 1 of the *Taxation Administration Act 1953* (Cth) (The Act) in respect of the year ending 30 June 2023 and has elected for the Fund to be an attribution managed investment trust for the year ending 30 June 2023.

Set out below are the taxable components of the distribution to be paid on 19 April 2023. These components are provided solely for the purposes of Subdivision 12-H and Division 12A of the Act and should not be used for any other purpose.

For the purposes of Subdivision 12-H and Division 12A of the Act, this distribution includes “fund payments” in respect of the financial year ending 30 June 2023 of 0.063 cents per security.
